INTSHAYELELO

I-Promotion of Access to Information Act yango-2000 ("PAIA"), iPAIA isebezena ngenxa yecandelo 32 loMgaqosiseko, mgaqo lowo othi wonke umntu unelungelo lenkcazel egcinwe Ngurhulumente, kanye nenkcazel egcinwe ngomnye umntu (okanye inkampani ezimeleyo) xa loo nkcazel ifuneka ukuze umntu enze okanye akhusel into anelungelo layo.

I-PAIA ithi umntu ofuna inkcazel umele anikwe imvume yokufikelela kuyo nayiphi inkcazel yabucala, ukuba loo

nkcazeloyiyafuneka ukuze enze okanye akusele into aselungelweni layo. Kodwa ke, isicelo esikumila kunje simele sihambelane nemigaqo-nkqubo ekulo Mthetho. Le miyalelo ibhalwe kulandelwa iCandelo 51 lePAIA ukuze ichaze izinto ezifunekayo zeProtection of Personal Information Act yango-2013 Nemigaqo yayo, ingakumbi uMgaqo 4 ("POPIA").

Le miyalelo izakukuchazela ngohlolo lenkcazeloyegciniwego nangenqubo omele uyilandele ukuze ufilele kwinkcazeloyegcinwe yiNkampani enoxanduva lokuyilawula. Xa kuthethwa ngeNkampani kule miyalelo, kuthethwa nangeenkampani ezibhalwe kwiAnnexure A equikiwego nayo apha.

- i. Sicela uqaphele ukuba nangona iNkampani ithembise ukuvelisa uxwebhu olupheleleyo lwale mithetho, kungenzeka ukuba olu xwebhu lungapheleli. Ukuba kuye kwenzeka sazi ngayo nayiphi imithetho ekuvumela ukuba ufikelele kwinkcazelotu ngenye indlela, ngaphandle kowe-PAIA, siza kuluhlaziya olu xwebhu.

Icandelo 66 lePAIA lithetha ngokukhuselwa kwenkcazel enxulumene nokukhuseleka kwantu, nokukhuselwa kwesaskhiwo.

Icandelo 67 lePAIA lithetha ngokukhuselwa kweengxelo ezibalulekileyo ezingenakusetyenziswa ekuxoxweni kwetyala enkundleni.

Icandelo 68 lePAIA lithetha ngokungavumi ngencazeloyezentengiso yeNkampani ukuba loo nkcazeloinemfihlo zorhwebo, inkcazeloyezemali, intengiso, okanye eyesayensi ngaphandle kwencazeloyezorhwebo, ukuba ukunikezela ngaloo nkcazelokungachana ngandlel' ithile kumba wezentengiso nakowezimali iNkampanileyo; inkcazeloenokuchana iNkampanikukhuphiswano lwayonezinye; okanye inkqubo yesoftware yeNkampaniekhuselwe ngecopyright.

Icandelo 69 lePAIA lithetha ngokukhuselwa kwencazelo edibene nophando lweNkampani okanye omnye umntu, nkcazeloleyo ekunokuthi ukuba ingakhutshwa ichane ngendlela embi iNkampani okanye loo mntu wenze olo phando.

Zonke izicelo zokufumana inkcazeloziza kuhlolwa ngokwemeko nganye nangokuhambelana nemigaqonemithetho. Izicelo ekucace gca ukuba zezokuphazamisa nje okanye ekunokuba kudlalwa ngemali ukuba zingahoywanzinokukhatywa.

enxibeleleni naloo Mntu okanye iNkampani;

- a) iingxelo zeeNkcukacha Zobuqu azimele zigcinwe ixesha elingaphezu kwelo lifunekayo
- b) ukuze kwenziwe injongo ebeziqokelelwe zona ngaphandle kokuba—
 - i. umthetho unyanzelisa ukuba zigcinwe;
 - ii. loo mbutho ufuno ukuba izo kuyidinga le ngxelo ngokweenjongo ezssemthethweni ezinxulumene neenkubo zavo;
 - iii. ukugcinwa kwengxelo kuyimfuneko ngenxa yesivumelwano saloo mibutho; okanye
 - iv. umnikazi weenkcazelo uyavuma okanye ukuba inkcazelo leyo yeyomntwana, zinokugcinwa xa umntu ommeleyo evuma.
 - (iv) Inkampani iyazitshabalalisa linkcukacha Zobuqu okanye izenze zingacaci ukuba zezikabani ukuba lidlulile ixesha lokuba igcine loo ngxelo;


